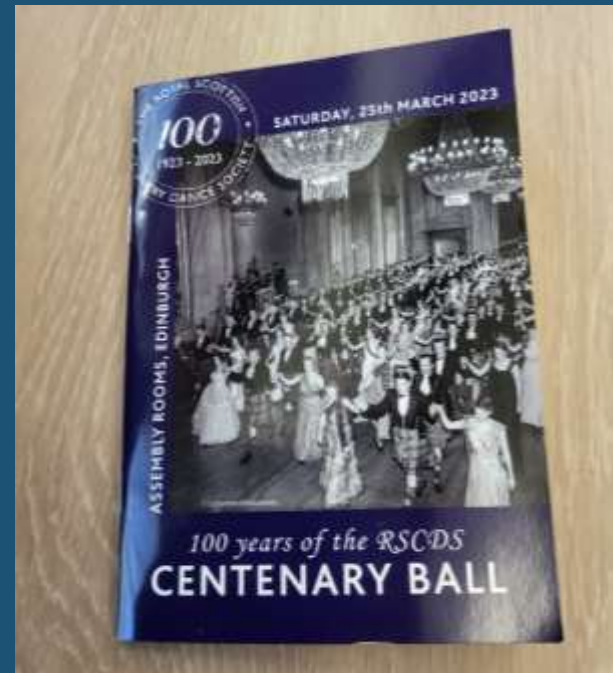

- Celebrating the Centenary of the RSCDS in style





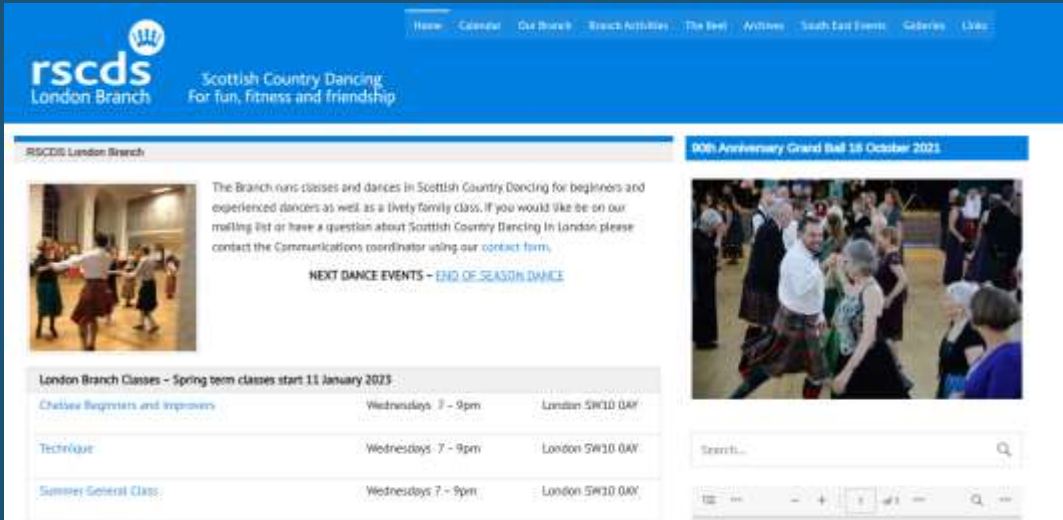
